



Service Agreement & Liability Waiver

This Service Agreement and Liability Waiver (the "Agreement") is entered into by and between Big Dog's In Home Canine Care LLC (the "Service Provider") and the dog owner/guardian (the "Client").

1. Services

The Service Provider agrees to provide the following services to the Client's dog(s):

- In-Home Dog Sitting
- Dog Walking

The specific dates, times, and details of the Services will be mutually agreed upon in a separate service booking or schedule.

2. Client Responsibilities

The Client agrees to:

- Provide the Service Provider with accurate and up-to-date information regarding the dog(s) health, temperament, vaccinations, and any special needs.
- Provide all necessary supplies for the dog(s), including food, medications, leashes, and collars.
- Ensure the dog(s) are current on all necessary vaccinations and preventative treatments (e.g., flea, tick, heartworm).
- Grant the Service Provider access to the home at the agreed-upon times for in-home services.

3. Liability Waiver and Release

The Client acknowledges and agrees to the following:

A. Veterinary Care

In the event of an emergency or if the Service Provider is unable to reach the Client, the Client authorizes the Service Provider to seek veterinary care for the dog(s) at the Client's designated veterinarian or, if unavailable, at the nearest available veterinary clinic or hospital. The Client agrees to be fully responsible for all costs associated with such veterinary care.

The Service Provider shall not be liable for any injury, sickness, or death of the dog(s) while under their care, provided the Service Provider has acted in a reasonable and non-negligent manner.

B. Dog Behavior

The Client acknowledges that all dogs are inherently unpredictable and that the Service Provider cannot be held responsible for any damage, injury, or loss caused by the dog(s) to persons, other animals, or property. This includes, but is not limited to, injuries incurred during walks or in the Client's home.

The Client warrants that their dog(s) have not demonstrated aggressive or dangerous behavior toward humans or other animals. If the dog(s) exhibit aggressive or dangerous behavior during the provision of Services, the Service Provider reserves the right to immediately terminate the Agreement without refund.

C. Property Damage

The Client holds the Service Provider harmless from any liability for damage to the Client's home or property that occurs during the provision of Services, including, but not limited to, damage caused by the dog(s) (e.g., house-soiling, chewing) or accidental damage caused by the Service Provider while performing their duties, provided the damage was not the result of gross negligence or willful misconduct by the Service Provider.

D. Indemnification

The Client agrees to indemnify and hold harmless Big Dog's LLC, its employees, and agents from and against any and all claims, damages, liabilities, costs, and expenses (including reasonable attorney's fees) arising out of or in connection with the Services, the dog(s), or the Client's breach of this Agreement.

4. Term and Termination

This Agreement shall commence on and shall remain in effect until terminated by either party. Either party may terminate this Agreement at any time by providing written notice to the other party.

5. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the state where the Service Provider is based, which is .
